Private OGID:

Public OGID:

5.2 DIGITALUNIVERSE: HUMANs operate as foundational actors within DIGITALUNIVERSE:

Collaborating with INTELLIGENCEs in ajurisdictional frameworks.

Leveraging DAOs and ORGANISATIONs for digital innovation, governance, and asset management.
